<u>Executive Summary: Eva García Chueca Case - ALICE Project and Relationship with Boaventura de Sousa Santos</u>

This document presents a detailed analysis of the professional and academic link between Eva García Chueca (EGC) and Boaventura de Sousa Santos (BSS), in the framework of the ALICE project, refuting statements made by EGC in media outlets such as Agencia Pública and the NOW channel, and in the 6th Letter of the Victims' Collective.

Public Accusations by Eva García Chueca.

EGC claims to have been a victim of symbolic violence, micro-abuses and academic marginalisation by BSS, including alleged kisses near the mouth, criticism for quoting other authors, and the non-publication of her thesis and non-fulfilment of institutional commitments.

Contradictions and Documentary Evidence.

The content of numerous emails contradicts the allegations made against BSS:

EGC expressed enthusiasm for his admission to the PhD (Exhibit 1: Email of 7 July 2011).

Her lack of attendance and commitment to the ALICE programme was often noted: frequent cancellations due to commitments in Barcelona and lack of adequate justifications (*Proof 2: Emails exchanged throughout 2012*).

EGC received constant support, including funding for courses and flexibility for work-life balance (Exhibit 3: Application and approval of course funding in July 2015).

Dear Eva

I have already read your text for Alice's Book of Human Rights. The question of the right to the city is an important contribution to our book. I believe, however, that the text can be strengthened after a reformulation that is entirely within your reach:

1. structure

The theoretical discussion of the text is poorly framed. My suggestion is that you reformulate the text having first a theoretical part, leaving the second half of the text for the discussion of the reality of Latin America and Brazil in particular:

2- Discussion.

In the passage on the European theoretical-political framework for Latin America, you only mention that this reality has become central in Latin America and Brazil, while in Europe it has remained a peripheral paradigm. I think there is a lack of explanation of how the critique of the decolonial and the epistemologies of the South come before the right to the city built on European foundations. In other words, you will have to strengthen the discussion on page 13 that only addresses some points in Lefevre's work, in order to take on a broader critique of Eurocentrism in the socio-political corpus of the right to the city in Europe.

3- Authors -

Given the impact it has had on your subject, it would be worth including a reading note on the work of David Harvey that expresses how you read him in your work.

4- Empirical material.

The information you provide on Brazil is very general. It would be good if, within the existing characters, you could provide something more unique to convey the added value of your fieldwork.

Publication and Academic Recognition.

Contrary to what was stated, the work of EGC was published as chapter 16 of the book *The Pluriverse of Human Rights*, where BSS is listed only as an organiser (Exhibit 7: Inclusion of EGC chapter in collective work coordinated by BSS).

If there had been any real animosity between BSS and EGC, or if BSS had appropriated her work, BSS would not have returned to Barcelona on 13 March 2019, at her own invitation. It was EGC who on that occasion presented the book *Global Learnings*, by Toni Aguiló and BSS. In the presentation, EGC is at pains to talk about what she learned from BSS, whom she considers her teacher.

Even after finishing her thesis, EGC kept in close contact with BSS, invited him to present books and left him a thank-you gift at CES. (*Exhibit 8: Mail of 1 August 2019*).

At 16:57 on 08/01/2019, Eva García Chueca wrote:

Eva García Chueca's public assertions do not stand up to the abundant documentary evidence that shows a cordial professional relationship, a flexible and generous supervision by Boaventura de Sousa Santos, and a clear lack of commitment by Eva García Chueca to the obligations of the ALICE project. The attempt to discredit the figure of Boaventura de Sousa Santos is belied by the records of communication maintained between the two parties over almost a decade, of which these are only an extract.
